A Message From The Director:

I recently saw a poster that said, "The world is run by those who show up." What a true statement. It refers to the squeaky wheels in the community who are present when decisions are made and priorities are set. These are the people who truly run things.

This month's newsletter showcases several opportunities not only to show up, but also to be heard on important issues that will affect St. Lucie County children over the next ten years. For the past twelve months, we have been using the Communities that Care framework to gather and assess data on risk and protective factors, as well as problem behaviors facing St. Lucie County youth. Collecting this data has been an immense undertaking, and we thank all who have been involved in that process. On April 7th and April 10th, we will give community practitioners, providers, educators and experts the opportunity to weigh in on the data, and recommend to the Roundtable which factors and behaviors require the most focus in terms of comprehensive, community-wide strategies. We will hold these "workgroup meetings" in the areas of Delinquency & School Dropout, Violence, Substance Abuse, Poverty, and Health. Please see page 2 for the schedule, and please "show up" for the meeting(s) that pertain to your areas of expertise.

In May, Roundtable members will have their annual retreat to review the data and recommendations of the workgroups, and begin selecting priorities for the next ten years. The Retreat will be held at VGTI-Florida in Tradition on Friday, May 8, 2015 from 8:30 AM to 12:30 PM and will be followed by lunch. We hope Roundtable members will make every effort to attend.

In addition, there are several other opportunities for you to "show up" over the next two months: the Know the Law Teen Forum at PAL (see page 4); the Reentry Resource Hub for offenders returning to society (see page 6); the Poverty Forum (see page 7); and the First Responders Training (see page 8). In fact, we have been overwhelmed by the positive community wide response and assistance on all of these events and we look forward to their success. If there is one thing we know how to do in St. Lucie County, it is *Show Up* and *Show Out*!

Are you aware that according to the U.S. Census Bureau, in 2013:

- Over 30% of all children in St. Lucie County lived in poverty
- The Poverty Rate for children in Fort Pierce was 54.6%
- Port St. Lucie's Poverty Rate for children was 24.7%
- Nearly 1 out of every 5 persons (19.3%) lived in poverty in St. Lucie County
- 32.4% of Fort Pierce and 16.8% of Port St. Lucie residents lived in poverty
- The poverty rates were higher than those for 2012


