


Y.Engage Youth Leadership Retreat

### **CADCA Partnering For Prevention**

February 5th-8<sup>th</sup>, Teresa and Kristy attended the 28th annual National Leadership Forum's "Partnering for Prevention" in Washington D.C. Under the leadership of Arthur T. Dean, retired Major General Chairman and CEO of CADCA, and presidential appointee Richard Baum, Acting Director of the National Drug Control Policy, the Forum was a huge success. Staff attended several incredibly informative and educational training sessions that were conducted by experts from around the United States. These sessions included "Transforming Culture and Building Healthy Communities with Positive Community Norms", "Leveraging Existing Prevention Infrastructure to Address the Opioid Crisis", "Implicit Bias Prohibiting Cross Sector Collaboration and Culturally Appropriate Prevention Strategies" and "Collaboration Across Communities".

Teresa and Kristy attended an intelligence debriefing from DEA Chief of Intelligence Officer, Doug Poole, who gave an overview of The National Drug Threat Assessment and provided recently unclassified information about drug cartels that provide corridors directly through the Treasure Coast.

The trip to Washington included a day on Capitol Hill and the House of Representatives. Leading up to Capitol Hill Day our very own Teresa Bishop was designated to prepare and educate all of the Florida delegates on the legislative issues that needed to be addressed on a federal level. They met directly with our local elected representative. The meeting provided the opportunity to educate Congressman Mast on how federal funding could positively impact the work that we do to minimize the effects of the drug crisis for our youth here in St. Lucie County.

Teresa Bishop's experience and knowledge are an integral part of national strategic planning and training efforts. Teresa's advice and insight were sought by top level staff and CEO of CADCA to help strategize training efforts to support coalitions around the nation.





# Y.Engage Youth Conference

The Roundtable was honored to host the Y.Engage Youth Conference at Children's Services Council from February 17<sup>th</sup> through 19<sup>th</sup>. Teenagers from Youth Leadership St. Lucie, Restoring the Village Youth Initiative, PACE Center for Girls, Men of the Sword, and Family of Faith Worship Center participated in this upbeat, relevant, and empowering event. The energetic training trio from Virginia enhanced the youth's knowledge and skills in the areas of civic leadership values, future-mindedness, civic activism, advocacy, youth mobilization, communication, and teamwork. The trainers encouraged the teens to utilize their voices appropriately and effectively so that they will be heard within their communities. The trainers also stressed the importance of not only words, but the teens have to put their plans into action. The community must see the investment teenagers are making in this county.

The teens engaged in team building activities, collaborative planning, and mobilization exercises during the training. Small and large group discussions, individual brainstorming, and documentation were a sample of the techniques used to demonstrate how a group can work together to achieve a common goal. The final training session was dedicated to showing the participants how to use Photovoice to spread their message of issues affecting them today. The teenagers from Fort Pierce will create a Photovoice display about the issues that are important to them, and the team from Port St. Lucie will create a display separately about the issues that are relevant to them. St Lucie's youth will be changed as a result of this training as these teenagers share with their peers and families what they have learned.

#### **More about Getting Ahead**

Getting Ahead (GA) is an agenda-free facilitated learning experience covering 16 sessions of three-hours each. GA groups generally meet twice a week. A diverse group of 6 - 12 people uses life experiences as the context for learning about the causes of poverty from both an individual and community perspective. Participants, called investigators, study change theory, hidden rules of class and the eleven resources that can be built to enjoy a stable future. Getting Ahead is a critical component of the Bridges Out of Poverty comprehensive model for reducing poverty through effective change at the community and individual level. Studies show that organizations from various sectors including business, corrections, education, health, legal, social services, and faith have improved outcomes for people in poverty who attend Bridges and GA programs.



# Florida Highwaymen Trail Art Show and Festival Student Art Contest

The City of Fort Pierce held the 3<sup>rd</sup> annual tribute to the Florida Highwaymen Trail Art Show and Festival on February 17<sup>th</sup>, 2018. The event featured many of the "original' and 2<sup>nd</sup> generation Highwaymen artists. It included an exhibit of Highwaymen Art Contest entries submitted by area 5<sup>th</sup> grade students who participated in the event's educational component. Each year, the city provides educational materials about the Highwaymen to 5<sup>th</sup> grade art teachers, as well as art paper and a gift card to purchase paint and paint supplies. As the students learned about the Highwaymen and their history in Fort Pierce, they painted landscape scenes that were entered into the art contest. The Lincoln Park Main Street Board judged the contest entries. The 1<sup>st</sup> place winner's art department won \$300; 2<sup>nd</sup> - \$250 and 3<sup>rd</sup> - \$200. Students with the winning entries received an engraved medallion commemorating the event and a \$25 gift card. All of the contest entries were displayed in a special exhibit at the event.







### A Place to Become...

Since founded in 1994, Boys & Girls Clubs of St. Lucie County have been at the forefront of youth development, working with young people from disadvantaged economic, social and family circumstances. With 19 locations throughout the county, more than 6,000 youth are served annually with Boys & Girls Club afterschool, summer, and outreach programs such as truancy prevention.

Boys & Girls Club programs focus on five core areas: Education & Career Development; Health & Life Skills; the Arts; Character & Leadership Development; and Sports, Fitness & Recreation. From individual tutoring and college field trips, to STEM activities and culinary training, Boys & Girls Club programs are designed to engage, inspire and empower kids and teens of all ages and interests. Two life-changing programs popular with Club members are Passport to Manhood and SMART Girls.

Passport to Manhood encourages boys age 8 to 14 to develop and mature into young men. With staff guidance, boys participate in discussions and activities that reinforce character, leadership and positive behavior. Each participant receives a "passport" to underscore the notion that he is on a personal journey of maturation and growth. The program's 14 sessions use interactive activities to focus on a specific aspect of character and manhood. It also includes a service project where boys learn the importance of giving back to the community.

SMART Girls is a small-group health, fitness, prevention/education and self-esteem enhancement program designed to meet the developmental needs of girls in three age groups, spanning ages 8 to 18. Through dynamic sessions, participatory activities, field trips and mentoring opportunities with adult women, Club girls explore their own and societal attitudes and values as they build skills for eating right, staying physically fit, getting good health care and developing positive relationships with peers and adults.

### St. Lucie County's Bike Share Program Gets Peddling in Fort Pierce

FORT PIERCE – Don't let the lack of a bicycle stop you from peddling around St. Lucie County. St. Lucie County's Transit Division has partnered with Zagster on a two-year pilot program that will create nine bicycle rental stations throughout the county.

Bicycle share stations have already been installed in downtown Fort Pierce near the City Marina and on South Hutchinson Island at the St. Lucie County Aquarium and Jaycee Park. Additional stations are in the works in Fort Pierce, including one at Jetty Park and the Beth Ryder Intermodal Facility on Avenue D. The city of Port St. Lucie will host four bike stations at Sportsman Park, Whispering Pines Park, the Port St. Lucie Intermodal Facility and the Port St. Lucie Civic Center. City crews are working with Zagster to pour concrete slabs for these stations with plans to have all of the stations and 50 bicycles available by early March.

The cost to rent a bike is \$1 per hour. Bicycles can be rented by downloading the Zagster app or via <a href="www.zagster.com/stlucie">www.zagster.com/stlucie</a> and text messaging. Instructions are also available on signs located at all bike share stations.

Bicycles can be returned to any of the stations located through the county, meaning residents can even use the Treasure Coast Connector, as all fixed route buses feature bike racks.

St. Lucie County's bike share program is a two-year pilot program. The Florida Department of Transportation's Intermodal Development Program provided capital financing for the purchase of six bike stations and 35 bicycles, as well as one-year of operating costs for those stations. Additional funding is currently being sought through sponsorship opportunities. If a local business or organization is interested in promoting the bike share program, sponsorships are available, which includes a business name/logo on a bike station sign and bicycle baskets to acknowledge their generous contribution in supporting the program, as well as their commitment to the local community. The bike share system is designed to promote public health, recreation, provide an affordable non-motorized travel option for short trips, and improve access to the county's fixed-route bus service, which is now free thanks to a two-year pilot program and Florida Department of Transportation grant.

A young person you know could be experiencing a mental health challenge or crisis. You can help them.


Youth Mental Health First Aid introduces common mental health challenges for youth, reviews typical adolescent development, and teaches a 5-step action plan for how to help young people in both crisis and non-crisis situations and connect them with the appropriate professional, peer, social, or self-help care. Anyone can take the 8-hour Youth Mental Health First Aid course, but it is ideally designed for adults who work with young people, ages 12-18 — teachers, coaches, leaders of faith communities, health and human services workers, social workers, and other caring citizens.

Sometimes, the best first aid is you. Take the course, save a life, strengthen your community.



The Lincoln Park Council for the Common Good is pleased to announce the BOOM! funding initiative, which will invest up to \$500,000 in a BOOM! idea addressing one or more of the three following community priorities and strategies:

Priority 1: Quality Jobs and Livable Wages: All Lincoln Park residents will have access to quality jobs that earn them livable wages.

#### Strategies:
