

Measure of America, with support from Schultz Family Foundation, analyzed data to estimate the economic, social and health costs of youth disconnection. The data indicates that an important indicator of a community's health is the degree to which its youth and young adult

population is furthering their education and securing their position in the working world.  $^{\rm 2}$ 

#### **Objectives Emerging**

Research, data analysis and meetings with the TPPN<sup>3</sup> have resulted in the emergence of objectives for this area of focus. To date, these objectives focus on (1) increasing access to reproductive and clinical health education services for all (2) building pathways between pregnancy prevention/clinical services and educational/career development opportunities (3) increasing proven community messaging that supports the value of delaying pregnancy. As these objectives are being tackled, it will also be important to ensure that outcome measures include post program follow up measuring whether or not program completers did or did not have a child (including becoming a father) or become pregnant. Baseline data is currently being collected, aggregated and analyzed. B2P members again thank *Tonya Andreacchio* and the Children's Services Council of St. Lucie County for their generosity of time and sharing needed data.

#### Not A Lab Rat Day Exposes How History Is Repeating Itself When It Comes to Vaping By Esteban Mendez

The second annual "Not A Lab Rat Day" was held on Wednesday, October 16<sup>th</sup>. At this year's event, Students Working Against Tobacco (SWAT) wanted other teens to know that when it comes to e-cigarettes, aka "vaping" products, history is repeating itself.

E-cigarette companies use the same tricks, including flavors and marketing campaigns, tobacco companies used for decades to target and recruit young smokers. Not a surprise considering Big Tobacco companies own or have significantly invested in e-cigarette companies. These are the same tobacco companies that for decades lied about the addictiveness and health effects of cigarettes.

SWAT is Florida's youth-led movement to combat Big Tobacco. Not A Lab Rat Day is a statewide initiative that empowers youth to stand up and declare that they refues to be the tobacco and e-cigarette industry's "lab rat" as we wait and see the long-term health effects of vaping.

SWAT chapters across the state are holding events at their schools and in their communities to dispel myths and educate their peers about the e-cigarette industry's connection to Big Tobacco. In St. Lucie County, the SWAT chapter and school clubs conducted a multitude of activities such as; Not a Lab Rat social media countdown campaign, created a #FACT wall at one of St. Lucie County High Schools, and conducted an interactive presentation at one of St. Lucie County Middle Schools.

Here are the facts:


- Marlboro cigarette maker Altria purchased a 35% state in JUUL for \$12.8 billion in Decebmber 2018.
- Imperial Brands, the makers of Winston and Kook, owns the e-cigarette brand Blu.
- RJ Reynolds (RJR), the makers of Newport and Camel, owns the e-cigarette brand Vuse.

"The tobacco and e-cig industry swear they aren't targeting us, but their marketing, fake claims, and 15,500 flavors (and counting) shows otherwise," said Lisbet Figuerora, one of the SWAT leads at the County Chapter. "SWAT has a voice, and we are here to end the deception and take back our generation."

Youth vaping has increased dramatically across the country, including right here in St. Lucie County. E-cigarette companies claim their products are intended for adults, but alarming rates among teens tell a different story. About 25% of Florida high school students are vaping compared to 4% of Florida adults.

Participants in Not A Lab Rat Day events completed placards stating that they will not be "lab rats." SWAT plans to send placards collected statewide to the headquarters of major e-cigarette companies.

Not A Lab Rat will be observed annually on the third Wednesday of October to bring awareness to e-cigarette use among youth, encourage youth to stand up to Big Tobacco and the e-cigarette industry and to push for change within their communities.

Kristen Hadeed challenges traditional approaches to leadership with a simple premise: What we do doesn't matter; it's how we make people feel that makes the difference. Funny, bold and brutally honest, Kristen shares her experience as an entrepreneur and the practical tools she's developed to create a work environment where people thrive because they know their work matters—a place where everyone is a leader. What Kristen started as a way to help pay for those jeans soon became a company known for its industry-leading retention rate and its culture of trust, accountability and empowerment. She challenges her audience to reflect on the current culture and to be honest when discussing the things that need to change, leaving participants inspired to take action as soon as she leaves the stage.

# What's up with **UP**?



Did you know a student raised in household of low income has a 1 in 10 chance in graduating with their bachelors by the age of 25?



Versus a 7 in 10 chance for those raised in high-income households.

Household income is a factor in students' ability to complete their education uninterrupted because lower income students may have to juggle work obligations, parenting, and other duties that make it difficult to complete their degree.

Similar situations are why America is falling behind in education. In 1990, the U.S. was ranked #1 in the world in attaining four-year degrees among 25-34 year olds, but today we are ranked 12<sup>th</sup>. But if our educational system had the ability to connect their students of low income to additional resources that could help them overcome barriers that would normally derail them from successful completion, our country would be positioned as a leader in education again.

This type of educational system already exist, its called the Urban Educational Ecosystem. Its imperative for non-profit organizations, childcare, and transportation services to be factored as a necessary support that will propel the student to success.

#### **Rethink UP**

By the time a 20 year old from a low income household turns 35 years old, they will make an average of \$33,000 less than their peers that were raised in high income households.

That's like having a race where you start years after your peers. These are just some reasons why UP exist. We focus on connecting families to resources needed to become economically self-sufficient.

Just this year, our Success Training Employment Program (STEP) has lifted 31 households out of poverty to economic self-sufficiency. By partnering with Indian River State College for Career Pathways will propel our participants into lasting careers that will provide livable wages and our Success Coaches will connect them to resources needed to eliminate any barriers that could stop them from completing their education.
