A Message From The Director:

Extra, Extra, Read All About It! New developments for the Roundtable's Restoring the Village Youth Initiative (RTVYI): new home, new name, new funding! First, it is important that our community knows just how many agencies, organizations and private donors make this all possible through their partnership, financial resources and in-kind contributions that support the initiative. In 2014, the City of Fort Pierce and the Fort Pierce Police Department, in partnership with the Roundtable of St. Lucie County, received funding for 2 years from the U.S. Department of Justice (DOJ), Office of Juvenile Justice and Delinquency Prevention (OJJDP) to implement the Comprehensive Gang Model (CGM). This funding was renewed for another 2 years with the expectation that our local community would sustain the initiative completely once the federal funding ended this past spring.

Early on, the St. Lucie County Board of County Commissioners, Allegany Franciscan Ministries, the Roy A. Hunt Foundation, and the St. Lucie County Children Services Council invested additional financial resources to support an impactful implementation of the initiative. They continued to do so throughout the federal funding period, increased their investment to fill the financial gap after federal funding ended, and now have committed support for the new fiscal year.

I am grateful to announce that while the federal funding ended in March for implementation of the model, more community partners rose to the occasion to sustain the initiative. Joining our original funding and resource partners to keep the RTVYI going to date include the St. Lucie County Sheriff's Office, the Port St. Lucie Police Department, the Community Foundation of Martin and Greater St. Lucie, the Fort Pierce Housing Authority, St. Lucie County Department of Health, along with a number of private donors. We express gratitude to the City of Fort Pierce for housing the initiative in its infancy as we transition this month to our new location provided by the St. Lucie County Department of Health at the Gwenda Thompson Logistics Center. Thank you St. Lucie County Department of Health - we love our new digs!!!!

Next, thanks to all who submitted suggestions for renaming the RTVYI. We are close to finalizing a name that captures the essence of this magnificent partnership! Look out for the “Big Reveal” coming soon.

Why is sustaining this initiative important? The goal of the model is to reduce gang violence in our community through comprehensive strategies. At its core, however, is the provision of opportunities for young boys and men to connect with Outreach Workers who serve as mentors, advocates and essentially “treasure hunters”. The Outreach Team works tirelessly to engage the participants in pro-social activities, connect them with countless community partners and support their participation in education, employment and other efforts to build character and change the trajectory of their lives. What sometimes goes unsaid is that most of the participants in the initiative have experienced severe maltreatment, tragedy, abandonment and loss, leaving them feeling hopeless for the future. They are then labeled as “at risk” and end up as “juvenile delinquents”. RTVYI participants not only need accountability - a very important part of the initiative - but they also need lots of specialized support, resources and tools provided by or accessed through the initiative —to restore their “HOPE”.

Sustaining RTVYI and the implementation of the CGM is also important because it qualifies us for more federal funding to expand and build upon the work. We are excited to announce that we applied for and were awarded two grants from the U.S. DOJ OJJDP primarily for existing CGM sites in the amount of \$820,000 over the next 3 years. The grants will let us: (1) expand the initiative beyond the original target area of Fort Pierce to serving youth who live in Port St. Lucie and the unincorporated areas of St. Lucie County; (2) serve females involved in gangs and community violence; and (3) enhance the systems response to victims of gang violence and their families.

We would like to express our deepest gratitude to all of our public and private partners for your vote of confidence, financial resources and in-kind support. We will continue to stand together and declare that all kids are capable of success -- NO EXCEPTIONS!!

Trevor Banks, Jr from Resurrection Life Family Worship Center gave some inspirational words about how his father has helped to shape his parenting skills now. He said he has more of a profound respect for his father today since he became a father just a few months ago. Mr. Banks shared with the fathers that being an example for their children to follow in word and in deed is important because Fort Pierce needs them. The community was well represented. Resurrection Life Men's Ministry and the United Methodist Church sent men, the Sheriff's Office sent deputies, and also many grandfathers and uncles came out to support the children of St Lucie Elementary School.

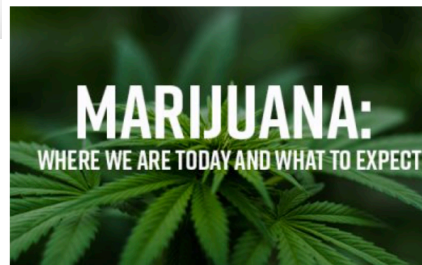

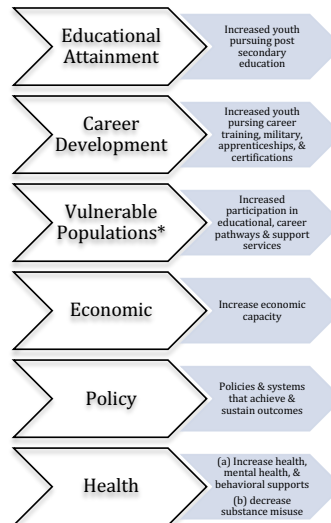
Roundtable Networks Collaborate

Strong partnerships are critical to identifying and building strategies for prevention and interventions to reduce youth disconnectedness. The Bridges to Prosperity Network (B2P) has initiated meetings with representatives of the (a) Child Welfare Network and the (b) Teen Pregnancy Prevention subcommittee of the Child & Adolescent Health Network as part of this process. Special thanks to Lisa von Seelen, Chris Martinez, Paul Nigro, Tessa Falatovich, and Tonya Andreacchio for their support.

The willingness of the Network members to share their time, knowledge and experience has provided insight into issues facing youth in foster care and pregnant and/or parenting youth - two populations vulnerable to becoming disconnected. B2P will be reaching out to the other Networks to identify shared strategies that will support increased educational attainment and embarkation on a career path.

Key Target Areas

Disconnected youth are teenagers and young people, ages 16-24, who are neither working nor in school. The B2P plan is to prevent and reduce youth disconnection by utilizing strategies that target the key areas below.



* This could include the following: (a) pregnant/parenting youth, (b) foster care youth, (c) homeless youth, (d) youth with disabilities.

Priority Funding Opportunity: Keeping Kids in School

The Children's Services Council is opening its priority area "Keeping Kids in School" for the 2020-2021 funding year.

The Children's Services Council has aligned its funding priorities with [community indicators](#). By funding and making available prevention and early intervention services, the Children's Services Council strives to ensure that these services have a positive impact on the community. The community indicators aligned with the priority area "Keeping Kids in School" are:

- School Absenteeism Rate
- Grade Level Reading Proficiency
- Academic Performance
- Kindergarten Readiness
- Graduation Rate
- Drop Out Rate

Agencies submitting proposals will be required to demonstrate how their proposed program's main focus and program impact are aligned, directly or indirectly, with one or more of the above community indicators. Proposed programs that cannot demonstrate their impact will not be considered for funding.

Funding for programs selected will begin October 1, 2020 through September 30, 2021. Program funding is on a monthly reimbursement basis. Additionally, funded programs will be required to submit quarterly outcome and demographic reports as detailed in the program contract.
